**EVENTS** Men's Singles, Women's Singles, Men's Doubles, Women's Doubles, Mixed Doubles
This tournament will follow USA Badminton's Tournament Regulations <a href="http://www.teamusa.org/USA-Badminton/Resources/Rules">http://www.teamusa.org/USA-Badminton/Resources/Rules</a>. Seeding will use USAB National Rankings as of March 7th, 2014. A feed-in consolation draw through the Quarter Finals will be adopted with prizes for first through fifth place finishers.



**ELIGIBILITY** Eligible players are US citizens and permanent residents who have not played in another country's Adult or Junior Nationals in the preceding 12 months and who have not competed under the flag of another country in this period. Also eligible are non-US citizens who have been continuously resident in the US and who have not competed under the flag of another country in this period. Continuous residency is defined as:

a) must have begun residence in the US before March 28th, 2013 <u>and</u>

b) must not have been out of the US for extended periods since March 28th, 2013. Vacations, playing in an overseas tournament, visiting a sick relative are acceptable absences, but leaving the country for a period of 1 month or more at a time is not acceptable.

US citizens and permanent residents (Green Cards) must enclose with their completed entry form a copy of the ID page of their US Passport / Green Card. Eligible players who are not US citizens or permanent residents (Green Card) must bring with them to the tournament their Passport which will be checked to verify eligibility.

Non-eligible players or players who cannot demonstrate eligibility prior to their first match will be disqualified.



**ENTRY** Completed entry forms with entry fee, waiver, and copy of Passport ID page / Green Card, **must be** mailed to <u>and received</u> by Chris Lawrence by <u>March 7th</u>. Mail to 7 Oak View Terrace, Franklin, MA 02038.

FEES The entry fee is \$80 per person for 1 or 2 events, and \$120 for 3 events, plus a \$15 administrative fee, and a \$5 USAB Court Officials Fee. Doubles partners must submit separate forms and fee. The fee includes a tournament T-shirt (indicate size on entry form). No refunds after March 21st. All players must be current members of USA Badminton (USAB) – sign up or renew before 3/28/14.
